2021 SA SENIOR CHAMPIONSHIP / SENIOR ACADEMY TOURNAMENT

We are all looking forward to the upcoming SA Senior Championship which will take place from the 3rd to the 9th of April 2021. The question is 'will it be safe or not to participate'? Unfortunately, we can't wait till the last hour, of decision, to start with the arrangements.

We, JSA, received an extra amount of R300 000 from SRSA to be utilized in promoting Jukskei amongst the Black, Colored, and Indian members. A decision was made by the Board of Directors JSA to invite one team per Province, to participate in the SA Academy Tournament.

The teams must consist of three men and three women including two officials, a coach and a manager. One of the officials must be a man and the other one a woman.

The only members that are eligible for selection must be from Social, or Senior clubs, with registered members that are affiliated with the District or Province. These Federations will determine when, where and the format of the trials for the selection of the players and the officials. The transport to and from the venue, for the trials, will be for the account of the players, as well as the refreshments.

Seeing that these teams will be part of the SA Academy Tournament, JSA will pay the difference, if needed, for the members to be fully registered.
